DOE Class Waiver

- Requirement for user agreements is nothing new
- All guests must have some type of agreement in place in order to be able to work at BNL
- DOE class waiver http://www.gc.doe.gov/1002.htm
 - Non-proprietary user and the National Laboratory retain title to their own inventions and research data generated under nonproprietary research is made public
 - Proprietary users pay full cost for use of specialized laboratory equipment and, with limited exceptions, retains as proprietary the technical data generated, as well as the rights to any new inventions.
 - User facility guests have always worked under a class waiver



Key Comparisons

Old Agreements at BNL	New Agreements
First user signed agreement on behalf of institution	Institution must sign agreements. Guests sign acknowledgement form
No lifetimes	BNL implemented 5-year lifetime
Agreements are facility based	Agreements cover all facilities
Limited standardization across DOE complex	Better standardization across DOE complex
Changes were never requested	Changes cannot be done without DOE approval



Issues

- State versus federal law
- Foreign versus US law
- Intra-laboratory agreements
- Federally funded
- Federal agency agreements
- Facilities that are not DOE designated user facilities
- NYBlue is a state-owned facility
- Proprietary code for use on non-proprietary experiments
- Liability and indemnification issues for non-DOE owned equipment



Completion Status

684	active institutions
385	agreements in place
299	remaining to complete
104	in process (1/2 NSLS)
195	non-responsive (1/2 NSLS)
25	proprietary NSLS users
15	NSLS proprietary in place

*+/- 40 are intra-laboratory, federal agency, NASA-funded



Where Do We Stand

- DOE has approved extension of deadline from October 1, 2010 until December 31, 2010
- Discussions are underway with DOE Patent Counsel on indemnification and liability clauses and advance payments
